- ✓ *Members pay a Minimum House Assessment for food and beverage each year. The MHA is currently \$400.00 and must be used by December 31 each year.*
- ✓ *Cheque to be currently dated (no post-dated cheques) in the amount of \$2515.75*
- ✓ *Application form must be completed in its entirety.*
- ✓ *All applications are accepted on a first returned basis.*
- ✓ *Memberships are not transferrable.*

- ❖ Please note, this is an application for membership only. Its submission and subsequent does not entitle the applicant to membership in the Kelowna Golf & Country Club. All applications for membership in the Kelowna Golf & Country Club are referred to the Board of Directors, which reviews the qualifications and suitability of each applicant. The decision on whether to accept or reject an applicant is decided by the Board of Directors.

Associate Waiting List Members:

- ✓ Shall, upon acceptance to membership, pay such dues and other fees as prescribed by the Board.
- ✓ Shall be entitled to all social privileges of the Club.
- ✓ - Entitled to use the golf course twenty (20) times per year at the Associate member rate between the beginning of the season (which will be determined by the Board) and September 15. Before and after these dates, there is no limit of play. Appropriate green fees, as set by the Board of Directors for that year will be paid.
- ✓ Shall transfer to Regular, Regular Restricted, Non Resident or Social membership when their position in voting membership becomes available. If they elect to not transfer each time there is a position they are required to pay a further \$500 non-refundable deposit toward their eventual entrance fee. The option to remain on the waitlist expires after 5 consecutive years.
- ✓ Associate members, upon election to membership as hereinafter provided, and upon payment of entrance fee, dues, and other fees as prescribed for Associate members, shall be entitled to all social privileges of the Club, except that they shall not be entitled to vote or hold office or be heard at any meetings of the Club.
- ✓ An Associate member has no right to, or claim upon the Club, its property or funds.
