  - Pay the Non-refundable Entrance Fee Deposit of \$3,000.00, 2024 Annual dues and MHA. The deposit portion will be credited to the applicable entrance fee at the time of acceptance into voting membership.
  - The entrance fee is currently \$17,500.00. Spouse \$13,000.00 and can increase based on market conditions and cost of living increases. The dues and MHA are also subject to similar increases on an annual basis.
  - All Members pay a Minimum House Assessment (MHA) for food and beverage each year. The MHA is currently \$750.00 and must be used between January 1<sup>st</sup> and December 31. Unused MHA is absorbed by the Club at the conclusion of each calendar year.

The Board of Directors reserves the right to review the qualifications and suitability of each applicant and final approval on whether to accept or reject the applicant is at their discretion.

**Associate Waitlist Members:**

- ✓ Shall, upon acceptance to membership, pay such dues and other fees as prescribed by the Board.
- ✓ Shall be entitled to all social privileges of the Club.
- ✓ Entitled to use the golf course twenty (20) times per calendar year at the Associate member green fee rate, (January 1<sup>st</sup> to December 31<sup>st</sup>). Green fees, as set by the Board of Directors for each year will be paid.
- ✓ Shall transfer to Regular, Regular Restricted, Non Resident or Social membership when their position in voting membership becomes available. If they elect to not transfer each time there is a position they are required to pay a further \$500 non-refundable deposit toward their eventual entrance fee. The option to remain on the waitlist expires after the member has deferred voting membership twice. Following the deferral of two times the member must either join or resign from the Club.
- ✓ Associate Waitlist members, upon election to membership as hereinafter provided, and upon payment of entrance fee, dues, and other fees as prescribed for Associate Waitlist members, shall be entitled to all social privileges of the Club, except that they shall not be entitled to vote or hold office.
- ✓ An Associate member has no right to, or claim upon the Club, its property or funds.
